1. **Edna Inez Stratton**¹ was born on 14 Dec 1877 in Marlborough Township, Delaware County, Ohio. ^{2,3,4,5,6} She lived in St. Louis, Missouri on 13 Jun 1900. ⁷ She lived in St Louis, Missouri (according to the obit for her father) in 1914. ⁸ Edna lived in Laramie, Wyoming on 3 Jan 1920. ⁹ She lived in Justice, Hutchison County, Texas in 1930. ¹⁰ She lived in Amarillo, Texas in 1932. ¹¹ Edna lived in 3827 Ozark Trail, Amarillo, Randall County, Texas in 1966. ¹² She died on 27 Feb 1966 at the age of 88 in Northwest Texas Hospital, Amarillo, Potter County, Texas. ^{13,14} She was buried on 1 Mar 1966 in Llano Cemetery, Amarillo, Texas. ¹⁵ Edna was a Housewife. NOTES

The birth record from Delaware County, Ohio says she was born 14 Dec 1877. The date that appears in a family bible and was transcribed by Edna herself is 14 Nov 1877. The date that is given on her death certificate is 14 Nov 1877 (the informant is her son, Frank M. Morgan). The birth record is in a ledger, and was recorded months after the birth.

According to her son, Frank Morgan, Edna's first marriage broke up because of the death of her daughter (Anna Margaret). Frank Morgan said his mother and Wilbur Stephens were not happy after that loss.

According to the obituary for her father (July 1914) Edna was living in St Louis. By January of 1920 she was married to McLain Morgan and had one-year-old Edna Eleanor Morgan.
